NJROTC CADET STATEMENT OF UNDERSTANDING





I understand that in order for my son/daughter to be transferred out of NJROTC that I must contact one of the NJROTC Instructors by email or contact the school via his/her Guidance Counselor. I understand that all uniforms, textbooks, etc. are United States Navy property and are controlled items that must be turned back in. The uniform must be dry cleaned and kept in the plastic from the cleaners. Once my son/daughter returns all the items properly to the NJROTC Instructors, they will notify the Guidance Department that the student is cleared to be transferred to Gym. If items are never returned an obligation for the total amount will be placed on the student and NJROTC will ask to withhold student grades until all NJROTC property is returned.
